Regional Overview

The Goldfields region of the WA Country Health Service covers the Goldfields-Esperance Region of Western Australia. The region is located in the south eastern corner of Western Australia and covers 770,488 sq km (including offshore islands). The WA Country Health Service Goldfields consists of two main health campuses located in Kalgoorlie & Esperance, and three smaller hospitals located in Laverton, Leonora and Norseman. The Goldfields is a culturally rich region with a number of Aboriginal communities spread out across the region, 16 distinct Aboriginal language groups and an Aboriginal population that represents 12.3 per cent of our total population, with 1 in 10 people, on average, identifying as Aboriginal – this in comparison to the state average of 3.6 per cent. The region supports a wide range of industry, including mining, agriculture, aquaculture and tourism. Mining is the predominant sector in the central and northern parts of the region, with a well-established agricultural sector in the south.

Key Duties/Responsibilities

- 1. Leads and manages a multi-disciplinary ward service. Works collaboratively with all inter-disciplinary teams within the region.
- 2. Provides clinical leadership to medical, nursing and allied health professionals in cancer care within the region.
- 3. Provides advanced and complex patient care, advice and direction within cancer care.
- 4. Initiates and analyses research to determine clinical best practice; initiates, implements and evaluates best-practice activities that support the delivery of appropriate clinical care in cancer within the region.
- 5. Maintains excellence in interpersonal skills and use of leadership to guide appropriate patient care and service delivery. Maintaining strong communication with the network of Oncology Nurse Coordinators.
- 6. Promotes and facilitates an inter-disciplinary team approach to decision-making.
- 7. Develops innovative techniques for complex problem solving for oncology services within the region.
- 8. Develops, implements and promotes evidence based standards and policies that are compliant with relevant professional, industrial and legislative requirements for the region.
- 9. Provides leadership in the coordination and implementation of quality improvement activities.
- 10. Operates within the allocated / available budget for oncology services.
- 11. Actively participates in the recruitment, selection and orientation of staff as required.
- 12. Develop and implement business plans and strategies to facilitate effective utilisation of allocated human, financial and physical resources consistent with clinical unit, division and corporate facilities within the regional health service.
- 13. Provide clinical information, statistics and reports as required by WACHS and WA Cancer & Palliative Care Network.
- 14. Implements and maintains performance management systems which support the ongoing development of staff.
- 15. Develops, implements and evaluates education and training programs related to the area of oncology.
- 16. Provides a public relations function for the area including investigation and management of ministerials, enquiries and patient complaints and compliments.
- 17. Use effective change management strategies to improve practice within the region.
- 18. Responsible and accountable for attendance of self and line managed staff to mandatory training programs during a twelve month period.
- 19. Other duties as directed by the Regional Director Nursing & Midwifery or their delegate.
