#### KEY RESPONSIBILITIES

Develop and co-ordinate the implementation of the traffic signal operations strategy, including policies, processes and guidelines that will improve the efficiency and safety of the existing road network as part of an integrated transport system. Provide specialist advice in traffic signal operations and develop internal staff capability and technical competence in signal timing configuration.

#### **Traffic Signal Operations Planning**

- Develop the Traffic Signal Operations Strategy and co-ordinate the research, and development of policies and guidelines associated with the strategy in order to effectively manage traffic signal operations on the road network.
- Provide specialist advice for standards, systems and policies regarding signal operation.
- Ensure traffic signal timing configuration adhere to guidelines and policy, by undertaking system audits and recommending remedial action, where required.
- Review signal timing operation processes for the capability to meet current and future operational objectives.
- Develop and maintain processes for traffic signal timing optimisation and audit reviews.
- Co-ordinate inter-agency activities associated with traffic signal operations to foster closer integration with broader planning objectives.

### **Training and System Access**

- Facilitate the retention of required knowledge levels for service delivery of traffic signal operations.
- Develop and facilitate the traffic signal operations training program to upskill and maintain team and individual competence in traffic signal operation.
- Determine individual staff level of competence in traffic signal operation and facilitate appropriate level of access with the System owner.
- Ensure the effectiveness and consistency of traffic signal operation access across multiple teams and individual staff members.

#### Leadership and Management

- Provide technical guidance in development and implementation of Traffic Signal Operations policies, strategies and associated guidelines to achieve corporately agreed visions and targets.
- Manage financial, technological, physical and other resources within agreed allocations to meet agreed outcomes.
- Manage employee behaviour, performance and development.

## **Stakeholder and Community Relationships**

- Build and enhance professional working relationships with internal and external stakeholders.
- Engage with internal and external stakeholders on traffic signal operation matters.
- Represent the Manager and contribute to the relevant Austroads and other national projects/committees.
- Represent the Manager on external committees, working parties, public meetings and workshops.
- Prepare advice for Main Roads on network operations policy and strategy.
