- Seek to understand and influence key design issues and trends by working closely across government, agencies and partners.
- Provide strategic leadership of the State Design Review Panel (SDRP) processes, including chairing panel sessions and communicating SDRP recommendations.
- Attend sittings and provide advice on special matters at Development Assessment Panels as required.
- Advise on planning policies relating to the design and built environment.
