Description

The Principal Planning and Engineering Officer is responsible for leading and managing the day-to-day operation of transport and road planning projects and high level stakeholder engagement.

- Manages sensitive and complex transport projects, urban transport network and corridor planning with a focus on design concepts, land reservation requirements.
- Leads statutory processes for transport reservations such as Metropolitan Region Scheme amendments for regional roads, including the consultation processes and environmental and planning approvals.
- Coordinates capital investment assessments and budgetary planning for urban transport infrastructure.

Strategic Advice

- Prepares Ministerial and Departmental briefs and responds to correspondence.
- Researches, formulates, monitors and reviews relevant policies, strategies, guidelines and innovative practices and assesses their relevance to the Department and State.
- Provides technical advice and recommendations on transport modelling, traffic engineering, transport planning and road design matters to a range of stakeholders both internally and externally.
