## Brief Summary of Duties (in order of importance)

### 1. Specific Duties/Scope of Practice Relevant to Speciality

- 1.1 Provides quality Midwifery care, in conjunction with the Clinical Midwives to allocated woman within the Midwifery group.
- 1.2 Identifies, plans, implements and evaluates, in conjunction with other members of the health team, appropriate woman centred midwifery care.
- 1.3 Provides a clinical decision making approach, providing holistic Midwifery care within the group.

### 2. Clinical

- 2.1 Provides comprehensive evidence based midwifery/nursing care to patients including assessment, intervention and evaluation.
- 2.2 Undertakes clinical shifts at the direction of senior staff and the Nursing Director including participation on the on-call/afterhours/weekend roster if required.
- 2.3 Participates in ward rounds/case conferences as appropriate.
- 2.4 Educates patients/carers in post discharge management and organises discharge summaries/referrals to other services, as appropriate.
- 2.5 Supports and liaises with patients, carers, colleagues, medical, nursing, allied health, support staff, external agencies and the private sector to provide coordinated multidisciplinary care.
- 2.6 Completes clinical documentation and undertakes other administrative tasks as required.
- 2.7 Participates in departmental and other meetings as required to meet organisational and service objectives.
- 2.8 Participates in quality improvement and policy review/development within the practice setting.
- 2.9 Complies with and demonstrates a positive commitment to Regulations, Acts and Policies relevant to nursing including the Code of Ethics for Midwives in Australia, the Code of Conduct for Midwives in Australia, the National Competency Standards for the Midwife and the Poisons Act 1964.
- 2.10 Promotes and participates in team building and decision making

### 3. Education/Training/Research

- 3.1 Engages in continuing professional development/education and ensures continuous registration in the category of Midwife with the Nursing and Midwifery Board of Australia per essential criterion 1.
- 3.2 Participates in supervision, professional development and clinical consultation activities with the supervising senior midwife.
- 3.3 Assists with supervision and development of undergraduate nursing students as directed by senior staff.
- 3.4 Plans, develops and implements education programs for patients/colleagues/consumers.
- 3.5 Participates in evidence based clinical research activities where applicable.

**4. EMHS Governance, Safety and Quality Requirements**

- 4.1 Participates in the maintenance of a safe work environment.
- 4.2 Participates in an annual performance development review.
- 4.3 Supports the delivery of safe patient care and the consumers' experience including identifying, facilitating and participating in continuous safety and quality improvement activities, and ensuring services and practices align with the requirements of the National Safety and Quality Health Service Standards and other recognised health standards.
- 4.4 Completes mandatory training (including safety and quality training) as relevant to role.
- 4.5 Performs duties in accordance with Government, WA Health, East Metropolitan Health Service and Departmental / Program specific policies and procedures.
- 4.6 Abides by the WA Health Code of Conduct, Occupational Safety and Health legislation, the Disability Services Act and the Equal Opportunity Act.

## Work Related Requirements

3. Demonstrated effective interpersonal, negotiation and conflict resolution skills.
4. Demonstrated effective written and verbal communication skills.
5. Knowledge and experience in the Quality Improvement Cycle and Patient safety initiatives.
6. Willingness to practice in accordance with the Midwifery team preferred view i.e. that of being Professional, Empowering Women, Caring and Friendly, Collaborative, Positive Team Role Modelling and Holistic Midwifery.
7. Current "C" or "C.A." class drivers licence.

### Desirable Selection Criteria

1. Relevant skills in computer literacy.
2. Current knowledge and commitment to Equal Opportunity in all aspects of employment and service delivery.

### Appointment Prerequisites

Appointment is subject to:

- Evidence of current registration by the Nursing and Midwifery Board of Australia must be provided prior to commencement.
- Working with Children (WWC) Check, compulsory check for people who carry out child-related work in Western Australia.
- Evidence of current "C" or "C.A." class drivers licence.
- Completion of 100 Point Identification Check.
- Successful Criminal Record Screening Clearance.
- Successful Pre-Employment Integrity Check.
- Successful Pre-Employment Health Assessment.
