- Reviews complex infrastructure planning proposals, Transport Management Plans, Transport Impact Assessments and Statements.
- Undertakes Metropolitan Region Scheme amendments for regional roads, preparing and presenting reports to the Western Australian Planning Commission as required.
- Collaborates and engages with internal and external stakeholders to develop, implement and deliver outcomes on transport statutory and strategic processes and projects.
- Responds to general enquiries on transport planning and traffic engineering matters.
