Key Responsibilities

The position occupant will be expected to undertake inpatient and outpatient reporting as instructed and supervised as well as undertake diagnostic imaging procedures such as ultrasound and perform interventional procedures. Applicants will be required to assist in providing an on-call and emergency diagnostic and interventional medical imaging service.

Brief Summary of Duties (in order of importance)

- Undertakes inpatient and outpatient reporting as instructed and supervised by a Department Radiology Consultant.
- Undertakes diagnostic imaging procedures such as ultrasound, fluoroscopic screening and other diagnostic procedures.
- Provides emergency clinical assessment and medical care of Diagnostic Imaging outpatient and inpatients, as required.
- Administers intravenous contrast for imaging procedures as required.
- Obtains consent for Diagnostic Imaging and Interventional procedures as required.
- Admits, examines and manages Diagnostic Imaging day cases and inpatients under the supervision if an interventional radiologist is required.
- Performs interventional procedures under the supervision and instruction of a Department Radiology Consultant.
- Participates in departmental meetings, teaching, including the weekly clinical review and journal club.
- Participates in quality assurance projects and implements strategies which will contribute to the assessment and improvement of departmental services.
- Participates in professional teaching activities, including the teaching of medical students, nurses, allied health staff and trainee medical staff.
- Participates in ongoing active research programme in collaboration with the University of Western Australia in diagnostic and interventional medical imaging.

- Participates in the maintenance of a safe work environment.
