

Position Overview

Contribute to the provision of pharmaceutical services provided by participating in drug distribution, inventory control, PBS claim processing, dispensing processes and undertaking specific duties as rostered.

Key Duties/Responsibilities

1. Maintains stock inventory of all pharmaceuticals and consumables by participating in the order and receipt process, stock rotation, expiry date monitoring and redistribution of drugs to areas of high use.

- 2. Facilitates Imprest stock of pharmaceuticals including S8 and S4R medications, in wards, theatres and departments by ensuring their proper ordering, distribution and rotation according to local policy; sets stock levels by liaising with the pharmacist and nursing or medical staff where relevant.
- 3. Ensures that prescriptions conform to legal and hospital requirements and that the prescription documentation requirements of PBS Reform are met. Performs calculations/balancing for correct dosing of medication. Prepares prescriptions and/or items for ward issue, including SAS, S4R and S8 drugs, up to the checking stage and maintains appropriate records according to local policy under the supervision and direction of a pharmacist.
- 4. Assists in the generation and maintenance of PBS claims including the correction of rejected claim items, maintenance of back claims and generation of PBS claim reports.
- 5. Repacks bulk drugs into smaller packs/units for distribution to the ward or other sites, under the supervision of a pharmacist and in accordance with the Code of Good Manufacturing Process.
- 6. Contributes to the maintenance of pharmacy records including prescription management, production of reports and development/maintenance of standard operating procedures.
- 7. Ensures the coordination of medication deliveries to regional sites including the safe and effective packaging of fridge lines to ensure cold chain is maintained with appropriate monitoring.
- 8. Undertakes stores responsibilities including generating purchase orders, liaising with vendors, receiving, and receipting orders, processing invoices, reviewing inventory held at locations across the region including pharmacy and clinical locations.
- 9. Supervises and /or trains other new pharmacy staff where required.
- 10. Participates in quality assurance activities, annual performance development review and mandatory training.
- 11. Coordinate the order and supply of chemotherapy/immunotherapy drugs and associated supportive care for cancer patients.
- 12. Undertakes rostered shifts and rotations in the Department/Unit at the direction of the Regional Chief Pharmacist including participation in the after-hours/weekend/public holiday roster and work at other sites as required.
- 13. Undertake audit activities under the direction of the Regional Chief Pharmacist.
- 14. Other duties as directed.

NOTE: Some or all of these duties will apply on a rotational basis.

Work Related Requirements

- 1. Completion or progression towards Certificate III Medical Technicians and Assistants or Certificate IV in Pharmacy Support or equivalent level qualification.
- 2. Experience using the iPharmacy inventory control and dispensing system.
- 3. Current knowledge and commitment to Equal Opportunity in all aspects of employment and service delivery.
