- Undertakes and/or co-ordinates research, collation, analysis, development and evaluation of data, issues, policies, practices, and/or procedures to provide recommendations for further consideration or action.
- Monitors, reviews and evaluates policies, strategies and initiatives, making recommendations for enhancement where appropriate.
- Provides high level analysis and policy advice to the Commissioner on research and data impacting on children and young people and makes appropriate recommendations.
- Undertakes research and consultations with children and young people and develops associated reports for publication and contributes to the development of discussion papers.
