Business Area Overview

Location Services provides trusted location data and spatial services to support the management and development of Western Australia to benefit the community. Land Boundaries maintains and raises the standard of cadastral and geodetic frameworks, surveys, plans and data, and creates and maintains the State's foundational location information.

Role Summary

The Principal Inspecting Surveyor is responsible for maintaining and raising the standard of cadastral frameworks, surveys, plans and data. This role applies qualifications and specialist skills to undertake cadastral integrity activities and provides specialist advice on complex cadastral survey and plan matters, in support of land titling and land development.

Responsibilities

- Undertakes surveying investigations and resolves significant issues for complex land and property matters.
- Applies specialist skills and knowledge to resolve highly complex and serious cadastral issues.
- Maintains a specialist level of skill and knowledge in:
 - Relevant WA legislation, regulations and practices.
 - WA cadastral surveying and information (including plans and field records).
 - WA land tenure, including Crown, freehold, strata and community titles, and interests on land.
- Audits, inspects and reports on complex cadastral surveys, plans and field records, to ensure maintenance of a high standard of surveys and plans.
- Requisitions practising Licensed Surveyors (LS) in respect to serious breaches detected during examination, inspection, auditing of surveys and plans, and provides counsel on required standards.
- Appointed by the Governor under section 18 of the *Licensed Surveyors Act 1909* to approve plans of authorised surveys.
- Appointed by the Minister of Lands under section 30 of the *Land Administration Act 1997* to approve Crown plans as an Authorised Land Officer (ALO).
- Provides specialist advice to internal and external stakeholders in relation to cadastral boundary matters, survey and plan standards and practice.
- As an ALO, provides direction or supervision to geodetic surveys undertaken by Landgate.
- Reviews applications for alternative survey methodologies (other than in accordance with regulations) and recommends Inspector of Plans and Surveys (IPS) approval or other responses.
- Reviews applications for Adverse Possession and Transfer of Land Act conversions and advises the Commissioner of Titles (CoT) on compliance with legislative survey and plan requirements.
- Designs, conducts and assesses examinations for the Land Surveyors Licensing Board (LSLB) examination process.
- Educates the cadastral surveying profession and related industries, on cadastral survey and plan requirements, by participating in relevant industry forums.
- Investigates, reports and provides recommendations on matters affecting the cadastral survey system, practices, specifications and survey regulations.
- Provides specialist surveying advice and evidence at Court and the State Administrative Tribunal, for

the CoT or LSLB.

- Certifies evidence for other government agencies (under their legislation) for Court purposes.
- Acts as a representative for the Surveyor General or IPS in various forums.
- Serves as a subject matter expert on cadastral reform initiatives including, legislation, policy, process and system changes.
- Adheres to Work Health and Safety (WHS) policies and procedures that ensures the safety of staff and customers.
- Acts with integrity at all times, demonstrates behaviours aligned with Landgate's code of ethics and works within relevant policies and procedures, contributing to the accountabilities of the team.
- Performs other duties as directed.
