#### **Business Area Overview**

Location Services provides trusted location data and spatial services to support the management and development of Western Australia to benefit the community. Land Boundaries maintains and raises the standard of cadastral and geodetic frameworks, surveys, plans and data, and creates and maintains the State's foundational location information.

### **Role Summary**

The Senior Inspecting Surveyor is responsible for maintaining and raising the standard of cadastral frameworks, surveys, plans and data. This role applies qualifications and expert skills to undertake cadastral integrity activities and provides expert advice on cadastral survey and plan matters, in support of land titling and land development.

### Responsibilities

- Undertakes surveying investigations and resolves issues for a range of land and property matters.
- Applies expert skill and knowledge to resolve technical issues related to cadastral surveying.
- Maintains an expert level of skill and knowledge in:
  - Relevant WA legislation, regulations and practices.
  - WA cadastral surveying and information (including plans and field records).
  - WA land tenure, including Crown, freehold, strata and community titles, and interests on land.
- Inspects and reports on cadastral surveys (re-establishment, accuracy, marking and presentation) to ensure a high standard of surveys and plans.
- Audits cadastral plans, and inspects field records, to maintain a high standard of survey information.
- Effects check, re-alignment and other cadastral surveys as required.
- Requisitions practising Licensed Surveyors in respect to breaches detected during examination, inspection and audit of surveys and plans, and counsels them on required standards.
- Provides guidance and expert advice to surveyors and other stakeholders on cadastral surveys and data, including preparing and presenting information of Landgate's requirements.
- Provides expert technical support on matters of cadastral surveying, measuring, instrument calibration and standards.
- Designs, conducts and assesses examinations for the Land Surveyors Licensing Board (LSLB) examination process.
- Consults with surveyors and other stakeholders on WA survey system requirements and prepares detailed technical reports and recommendations on cadastral infrastructure.
- Develops and maintains survey specifications, guidelines and practices that continuously align with modern survey practices.
- Delivers presentations to surveyors at survey industry forums and participates in industry meetings.
- Investigates, reports and recommends improvements for matters affecting the cadastral survey system, practice, specifications and survey regulations.
- Promotes and fosters an innovative culture with a commitment to continuous improvement from a
  people, process and system perspective aligned to Landgate's vision and strategy.

- Serves as a subject matter expert on cadastral reform initiatives and projects, including legislation, policy, process and system changes.
- Adheres to Work Health and Safety (WHS) policies and procedures that ensures the safety of staff and customers.
- Acts with integrity at all times, demonstrates behaviours aligned with Landgate's code of ethics and works within relevant policies and procedures, contributing to the accountabilities of the team.
- Performs other duties as directed.
