The Clinical Nurse Consultant-Oncology Coordination position is funded through a partnership with the McGrath Foundation. This position provides care, information, and support for people with cancer across the continuity of care pathways and multidisciplinary teams across the community and within remote Health Services.

The role provides advanced clinical cancer nursing knowledge with a remote remit for oncology services. The position demonstrates leadership and role modelling and promotes the maintenance of clinical standard setting and monitoring, policy development and change management to improve the cancer patient's journey.

#### **Key Duties/Responsibilities**

- 1. The role provides leadership that facilitates the ongoing development of clinical practice that reflects the McGrath Model of Care
- 2. Provides governance in the coordination of and remote and regional services. Works collaboratively with multi-disciplinary teams, ensuring the needs of the regional and remote patients are met and service planning can be optimised through a clear understanding of local context.
- 3. Provides clinical leadership to medical, nursing and allied health professionals in cancer care, contributes enhances access to new treatments, and facilities and develops partnerships with other service providers.
- 4. Provides advanced and complex patient cancer care , advice and direction.
- 5. Initiates and analyses research to determine clinical best practice; that support the delivery of appropriate cancer care, inclusive of auditing and reporting.
- 6. Maintains excellence in interpersonal skills and use of leadership to guide appropriate patient care and service delivery, maintaining strong communication with the network of cancer nurse.
- 7. Promotes and facilitates a multidisciplinary team approach to decision making inclusive of the promotion and support of telehealth and care close to home.
- 8. Develops innovative techniques for complex problem solving for cancer services and culturally responsive treatment strategies to improve outcomes.
- 9. Develops, implements and promotes evidence-based standards and polices that are compliant with relevant professional, industrial and legislative requirements.
- 10. Provides leadership in the coordination and implementation of quality improvement and patient safety activities and uses audit results to guide and support change in practice.
- 11. Contributes to the formulation of staffing profiles, according to analysis of clinical cancer needs and operates within the allocated/available budget for cancer services.
- 12. Actively participates in the recruitment, selection and orientation of staff as required.
- 13. Develops and implements business plans and strategies that facilitate effective utilisation of human, financial and physical resources consistent with WACHS strategic plans.
- 14. Provides clinical information, statistics and reports as required by WACHS, State and National Committees.
- 15. Implements and maintains performance management systems which support the ongoing development of staff.
- 16. Develops, implements and evaluates education and training programs inclusive of new and emerging treatment regimens.
- 17. Provides a public relations function for the area including investigation and management of ministerial, enquires and patient complaints and compliments.
- 18. Uses effective change management strategies to improve cancer nursing practice.
- 19. Responsible and accountable for attendance of self to mandatory training programs during a twelvemonth period
- 20. Other duties as required.

- 3. Understanding of preceptoring, orientation and clinical teaching programs.
