The Policy Officer undertakes research and policy development to enable the Commissioner for Children and Young People to perform functions under the Commissioner for Children and Young People Act 2006 (WA). The position analyses information, creates a range of written communications, and works with stakeholders across various sectors of the community.

Responsibilities

Research and policy development

- Conducts research, analysis and evaluation of a range of matters relating to children, young people and regulatory matters.
- Develops policy and provides advice, including to external agencies and bodies, making recommendations where appropriate.
- Monitors, reviews and evaluates policies, strategies and initiatives, making recommendations for enhancement where appropriate.
- Prepares reports, briefing notes and correspondence.
- Contributes to the development of a range of projects and participates as a member of project teams.
- Contributes to the development of the Commissioner for Children and Young People's strategic and business plans.

Working relationships

- Develops and sustains networks in the public, private and non-government sectors and works cooperatively and positively with all stakeholders.
- Supports engagement and consultation activities with children and young people.
- Applies effective and appropriate negotiation methods suited to a range of audiences, with an ability to influence outcomes.
- Participates as a member of a team, creating productive working relationships.

Other

- Maintains an awareness of issues affecting children and young people.
- Undertakes other duties as required.
- Represents the Commissioner as required.
